#### Powered Paraglider Instructor Course:

The BHPA has managed to secure the services and facilities of the team at Airways Airsports to run this course, under the guidance of three of the most experienced BHPA Senior Paramotor Instructors: Chris Dawes, Andrew Rastall and Andy Snell.

This course will take place at the Airways Airsports flight park at Darley Moor, Near Ashbourne, Derbyshire, commencing on Saturday 25th April and ending nine days later on Sunday 3rd May

The course is intended to equip candidates to the level where they are ready to be examined as a special category of BHPA Senior Instructor. (Individual Instructor examinations will need to be organised after the course, as required.) Please also note that, as previously advised, prerequisites are to attend a BHPA Coach Course, hold a BHPA Paraglider (Power) Pilot rating (previously known as SPHG 'full'), have 100 hours powered paraglider time logged and hold a valid First Aid certificate.
